THE NICK'S SCHOLARS (FORMERLY THE GUARDIAN SCHOLARS) PROGRAM PROVIDES MONTHLY IN-PERSON COACHING SESSIONS WITH A YOUTH ACADEMIC ADVISOR, MONTHLY STIPENDS AND RELATED SUPPORT, REFERRALS TO WRAPAROUND SERVICES SUCH AS TUTORING AND MENTAL HEALTH SUPPORT FOR STUDENTS CURRENTLY OR FORMERLY IN CARE WHO ATTEND CUNY COLLEGES. THE CHARLES EVANS EMERGENCY FUND PROVIDES AN EMERGENCY GRANT TO YOUTH WHO HAVE AGED OUT OF NYC FOSTER CARE - AND ARE EXPERIENCING A FINANCIAL CRISIS THAT COULD INTERRUPT THEIR EDUCATION. FUNDS DISTRIBUTED HAVE BEEN USED FOR HOUSING, TUITION, AND BOOKS AND ACADEMIC SUPPLIES. THE BACK TO SCHOOL PROGRAM PROVIDES LAPTOPS AND SUPPLIES TO YOUTH ENROLLED
