THE NICK'S SCHOLARS PROGRAM PROVIDES MONTHLY IN-PERSON COACHING SESSIONS WITH A YOUTH ACADEMIC ADVISORY, MONTHLY STIPENDS AND RELATED SUPPORT, REFERRALS TO WRAPAROUND SERVICES, SUCH AS TUTORING AND MENTAL HEALTH SUPPORT, TO STUDENTS CURRENTLY OR FORMERLY IN FOSTER CARE WHO ATTEND NYC COLLEGES. THE CHARLES EVANS EMERGENCY FUND AND THE IN CARE EMERGENCY FUND PROVIDE AN EMERGENCY GRANT TO YOUTH WHO ARE IN OR HAVE AGED OUT OF NYC FOSTER CARE AND ARE EXPERIENCING A FINANCIAL CRISIS THAT COULD INTERRUPT THEIR EDUCATION.
